## National Chairman

#### **SALVATION REVIVALS**

I came to faith in 1971 during the *Jesus Movement* when our western world and our own Australian society was facing some cataclysmic challenges such as the Vietnam war, the sexual and drug revolutions, and an anti-establishment ethos because of disillusionment with the structures of society, including the church.

The Lord moved sovereignly to draw millions of young people, hippies and other social groups into the church globally. But not all churches welcomed them. Those that did, exploded in spiritual growth and its effects are still being felt today, particularly in music, preaching and church facilities, purpose built for community.

I wrote in my book *Revival is our Middle Name* in 2020 that I sense another move is coming, and we as a CRC movement need to be ready for the influx of people the Lord will bring in. Revival is messy - as occurred during the *Jesus Movement* - and we need to be welcoming of people who have really been burnt by the prevailing culture and broken relationships, who are desperate for a spiritual encounter with Jesus.

There is, like in the 70's, global cultural and political angst and confusion about social roles and divisions in communities breeding fear and anxiety. In the middle of these challenges within society, we see across the western world Gen Z and Gen Alpha - particularly young men aged 18+, flocking into churches and in

Australia, church attendance has markedly increased over the past 6 years.

The assassination of Charlie Kirk, the number one Christian and social/political influencer among youth and young adults, is an inflexion moment. Charlie's grisly public murder shocked many of us deeply as he was a Pentecostal Christian and an awesome evangelist for Jesus. He was martyred while speaking to thousands of students at a university and it has immediately propelled hundreds of thousands of people, if not millions especially in the USA to flock into churches and purchase Bibles. We are seeing many people in Australia especially young men seeking after Jesus and searching for bible-based churches to attend.

This brilliant and highly popular 31-yearold's brutal killing could be a turning point for a new revival. Though we may have different opinions about some of his political opinions, he was a terrific witness of the good news about Jesus.

Over the next few weeks and months expect many visitors as Jesus **awakens** people to their need of HIM. I encourage all pastors and churches to take a fresh look at their welcoming, connecting and discipling ministries. Churches may need to make some changes to embrace these new hungry seekers the Holy Spirit will draw into our churches.

#### **CRC DEVELOPMENTS**

The CRC is expanding rapidly across the world. Pastor Phil Cayzer, our Australian Missions Director writes, "CRC Australia is active in over 97 nations, with 66 of these experiencing regular disciplemaking ministries and local church activity. The remaining nations benefit from short-term ministry and strategic support."

#### A NEW MISSIONS FRAMEWORK

We are currently improving the governance structure of CRC Missions to enhance effectiveness and accountability. We have discussed transitioning CRC Missions to operate as a **separate** incorporated entity, establishing a Missions Board, initially composed of the current Australian International Missions Team (AIMT) members. The National Executive will be the accountable body with power to appoint and remove members. Most denominations operate under this type of framework as it provides greater protection regarding funds raised for overseas mission ventures.

This will create clearer structural separation between our National Executive Office and our Missions Office. A **draft constitution** will be presented at this year's National Council, followed by a consultation period for National Council members to ask questions and make comments. Final endorsement is scheduled for the National Council AGM in 2026.

I also want to commend the great work of our Australian Mission's Office to you. They have recently set up a new system for sending money overseas for mission's purposes called **StoneX**. This is cheaper, quicker and safer than sending money through banks and it also helps run the administration of our Missions office.

Thanks to the churches that have given to help our Honiara, Solomon Islands CRC Church as our support project for this year.

#### FROM 'RETIRED' MINISTER TO 'EMERITUS' MINISTER

We have noted for some time now, ongoing confusion regarding the term "Retired" credential, which no longer aligns with legal requirements for ministers who are still active but are not on a paid salary, or leading a church. To address this, we are introducing the concept of an "Emeritus" credential. This new title better honours our long standing ordained Pastors as they are spiritual heroes of our denominational family.

#### **CHURCH PLANTING SCHOOL**

We are excited to announce the next **Church Planting School (Jan 5th – Jan 8th, 2026)**, which is an important opportunity to equip and train future church planters. Last year's attendees have either commenced new churches or are in the preparation phase. Participation

requires the approval of the registrant's Senior Minister and State Chair. We encourage all Senior Ministers of churches to prayerfully consider who would be suitable people to be involved in our next school. Registration details can be found at https://www.crcaus.com/planting

#### **HELPFUL GUIDELINES**

Our National Executive is aiming to regularly review our policies and guidelines over the next few years and to ensure all our Pastors and Churches are fully aware of their importance and are outworking these wise provisions.

To start this review process we have highlighted three as they are so **topical** at the moment: the Ministry Code of Ethics, the Known Offenders Guideline and the Sexual Harassment Policy. These really important documents are preventative rather than **remedial** after an unfortunate event. We would like all CRC Pastors to look over these documents and discuss them with your Church Boards and various ministry teams so they become familiar with the content. If you have any comments or feedback relating to them. please pass this on to your respective State Chair who can refer it back to the National Office.

## WORLD PENTECOSTAL CONFERENCE

It was my privilege to attend the Triennial World Pentecostal Conference in **Helsinki, Finland** earlier in the year.

There were over 5,000 delegates from around 100 nations across the world.

I'm so grateful to Jesus we are part of the 700 million strong Pentecostal denominations & charismatic groupings. The World Pentecostal Conference has a bold faith vision to 'reach every person on earth by 2033'... 2,000 years after the death, resurrection and ascension of Jesus, the outpouring of the Holy Spirit and the birth of Jesus Church. On present growth projections there will be 1 billion Pentecostal / Charismatic Christians by 2050

At the last conference (2022) in Seoul Korea I was appointed to be a member of the **Advisory Committee** representing the CRC and Australia's other Pentecostal movements...It's an honour to serve in this capacity.




Executive & Advisory Committees of the World Pentecostal Movement.

I am releasing my newest book, How to Protect Your Church. After 47 years of experience leading a church and 35 years as State and National Chairman, I have seen many examples of how



It has been a great joy serving with the Australian International Missions Team (AIMT) as we take bold, faith-filled steps toward our shared vision, "A CRC Presence in Every Nation by 2045." The unity of CRC Churches across Australia continues to bear lasting fruit—both locally and globally.

#### Where We Are Now

CRC Australia is active in over 97 nations, with 66 of these experiencing regular disciple-making ministries and local church activity. The remaining nations benefit from short-term ministry and strategic support.

The International Missions Bible College (IMBC) continues to expand, with over 7,000 students now enrolled. Our partnership with Vision International University (USA) has strengthened our global standing and clearly communicates our CRC identity to leaders joining our worldwide family.

## National Prayer & Missions Offering

In 2024, **\$70,000** was raised for the Port Moresby facilities project in PNG, aiding in the training of men and women for ministry.

This year's **National Missions Day Offering** supports the **"Isaiah 58 Solomon Islands Project"**, helping to build a new church and Bible college in Honiara. Materials are in place—we now believe for provision to pour the foundation and raise the structure.

In its second year, **Operation Proclamation** sent five teams to 17
African nations—strengthening churches, officiating IMBC graduations, and encouraging expansion. More teams are planned for **August–September 2026**.

We also thank the many churches currently undertaking short-term trips. If your church hasn't yet, we encourage you to start planning one!

#### **Funds Transfer Platform**

To meet ACNC External Conduct Standards, we now use a secure platform offering 7–15% better exchange rates than banks, allowing fund transfers to over 180 nations. Contact Mikeala Geno to get started.

#### Governance & Compliance

In response to evolving regulations, and in consultation with legal advisors and other movements, we are planning to incorporate the **CRC Missions** 

**Department** as its own entity under the CRC National Executive. This ensures legal compliance, clear accountability, reduced liability and opportunities for future growth (e.g. tax-deductible giving, international registration).

I want to sincerely thank the AIMT members—especially Mikeala Geno—for their excellent financial stewardship. Our strength lies in partnership, accountability, and obedience to God's call.

It is very rewarding to write and share with you some of the good news stories that have taken place in 2025 across several nations.

## National Conference and the 35th Anniversary of the CRC in the Philippines

More than 300 delegates attended this three-day event from every province in the nation, coming together in pure worship, dancing, celebration, and honouring all the churches, their pastors, teams, volunteers, and giving thanks to God for all He has done in the movement since its inception. The tremendous contribution of Australian churches, ministries, and missionaries to the development and growth of the CRC throughout the nation was also warmly acknowledged.

## The First National Conference in India

This bold venture involved moving a large number of people across vast distances in India. Some 52 pastors, leaders, workers, and students gathered from four different states and from Nepal for two days and 66

three nights of worship, fellowship, and teaching. Each delegate shared and celebrated the wonderful things God is doing, despite the many challenges, opposition, and internal pressures they face daily in such a vast and culturally diverse nation.

## Water Baptisms, Evangelism and New Churches

It is very encouraging and brings a great sense of pride to see the number of water baptisms that have taken place this year in Papua New Guinea, India, Nepal, the Philippines, and Fiji.

There is a renewed keenness to evangelise — one-on-one on the streets and through smaller open-air rallies, where still permitted.

There continues to be growth in the planting of new churches, particularly in the rural areas of Papua New Guinea over the last 12 months. New churches have also been planted in the Philippines, Cambodia, Fiji, and Nepal.

## Bold Witnessing by Young Indian Believers

It is especially encouraging to see young Indian men and women in their early and mid-twenties boldly sharing the Good News on the streets, one-on-one with all kinds of people. This is particularly notable among the young women, as traditionally they have been restricted from participating in public ministry.

Their compassion in reaching out to displaced persons — particularly the elderly — due to tribal conflict, extreme flooding, and destruction of homes, has been deeply moving. They are providing basic necessities such as food, clothing, shelter, and even biweekly bathing care for the elderly.

Natural disasters and conflicts are affecting people everywhere, and the church continues to be a source of practical and spiritual support.

#### **Training**

There is still a strong interest in training. This year, Bethel PNG has the largest

number of enrolled students in its history — 60 full-time, live-in students.

#### **New Missionaries**

Bethel PNG is actively training and sending missionaries to overseas mission fields.

Having recovered from the lost momentum during the COVID period — when there were no candidates for missionary training — we are now seeing new movement.

Over the past 12 months, a young woman from Bethel PNG has spent two threemonth periods (due to visa restrictions) in a restricted nation and is preparing for a third, completing a total of nine months. Another young woman from Fiji made two visits to another restricted country—one for six months and another for threemonths.

## Zoom Teaching – Overseas Countries

The regular weekly program of Zoom teaching of curriculum subjects in our training schools in India, the Philippines, Fiji, Nepal, and occasionally West Africa continues to be supported by lecturers from Australia, the USA, Fiji, PNG, the Philippines, and Nepal.

Pathways to Missions students and various pastors from several countries continue to visit, teach, and encourage CRC ministries in different fields.

Those who attended testified to the deep impact of his teaching and example.

#### Missions Exposure Trips

This year, two individuals undertook the option of a six-week Missions Exposure Trip. Unlike a short-term mission trip, these exposure trips connect participants into an established CRC base in another


nation, allowing them to experience life cross-culturally and be mentored by a missionary or pastor on the field.

We believe this pathway will continue to be a vital tool in preparing future missionaries and mission-hearted leaders.

# Church Planting

Planting new churches is central to who we are as a CRC movement. Our State Chairs and I are the action team to facilitate such an important aspect of our Strategic Directions.

It all began with our founder Leo Harris and a handful of people planting our first Australian Church in Adelaide in 1945...80 years ago. Many hundreds of Churches have been planted from that initial seed church, though they are not all in our movement.

Today we have around 140 Churches in Australia and our conservative estimate is well over 1,000 in the nations in which we are pioneering.

We launched our first Church Planting School last January and our second is in 3 months' time, from Monday night January 5th to Thursday night the 8th...Churches have and will be pioneered from the 11 men and women who attended our first one in January, 2025, and from the eager interest shown for our second one.

Two new churches will be launched in the greater Adelaide region early next year, and I'm aware of several others being prayerfully planned in our other States.

I believe it is more than possible for all our churches irrespective of their size to directly plant a church in the next 5 years, or to support another church to do it.... What a great faith goal for the glory of God and the extension of Jesus' kingdom across Australia.

I encourage every pastor and church to prioritise church planting by praying, planning and purposefully encouraging and inspiring some of your key leaders to step out and pioneer another congregation...When a parent church supports them like good parents do when their children leave home, and spiritually covers them, it becomes so much easier and fruitful.

CRC family let's rise with fresh vision and expectant faith, and step out trusting Jesus to work miraculously. As we embrace the New Testament Church apostolic pattern for revival, the Holy Spirit will open doors and provide in ways we can scarcely imagine.

## Christian Schools

There is a great opportunity before CRC churches to reach and disciple our nation through Christian schools.

We have some very capable churchschool organisations that are at the forefront of the Christian school movement in Australia. Adelaide Christian Schools has multiple schools in Australia and Papua New Guinea. They are a leading organisation in Christian education in South Australia.

Portside Christian College (PCC) has purchased land and expanded through a major new building project. This is a response to having limitePad options due to the lack of available land. The creativity of the leaders has resulted in a wonderful extension to the school. PCC is an excellent school and a beacon for Christ-centred education.

Lighthouse Christian College is a great initiator of new schools. They are currently working with Diggerland Church in establishing a new school in Red Cliffs. They also helped launch Verity Christian College (VCC) in Griffith, which is now operating under its own governance and organisation. VCC has been seeking other opportunities to expand in regional NSW.

The two campuses of Christway College, at Kingston and Wyndham, are growing and healthy. They are now working with a church in regional Victoria to plant a third campus. A new school is currently in development at Warragul, under the governance of Church on Tarwin called 'Aqueous Vitae Grammar' which is expected to open in 2026.

Three other CRC churches have incorporated schools into their vision for the future. This is very important and exciting for our strategic directions for 2023–28: **'Each one can plant one'**.

There is a great need for the Church to rise to the challenge of reaching and discipling our communities. Our nation needs Christ-centred education that presents a worldview placing God at the centre of human existence. As a movement, we will do what we can to support our churches that are maintaining a Christian ethos and purpose for their schools. Equally, we will support any of our churches in their endeavour to plant Christian schools in Australia or on the mission field.

Christian education is a central element in reaching our nation for Christ. At the very least, it gives young people a knowledge of God—but more importantly, it creates an opportunity for the revelation and reality of the power of the Gospel to transform their lives.

## Evangelism

Jesus is alive and moving in Australia, and the gospel is still God's power to save and transform those who believe!

Secularism promised freedom and selfactualisation, but has left hopelessness, uncertainty, and anxiety in its wake particularly for our younger generations. A growing meaning crisis in the West has created a deep spiritual hunger for real answers:

"People are... distracted by technology but left feeling hollow once the novelty wears off or addiction sets in. They are confused by the demands of fashioning their own identity when there is no pattern to follow and the rules keep changing. They are made anxious by a culture that demands ideological purity but extends no grace to those who fall short. They are exhausted by the search for a meaning they must invent and a purpose that seems to elude them. People can only take so much."

-Justin Brierley, The Surprising Rebirth of Belief in God

Despite a decline in Christian affiliation, Australians are still turning to Christianity in large numbers. Older generations are turning to Jesus more than we think, and youth are on a quest for meaning (McCrindle, 2025). While regional areas are moving away from Christian identity faster than inner cities, there has been an

increase in the number of 18–25-year-olds—particularly young men—going to church (NCLS).

More than two in five Australians (45%) are extremely or very open to spiritual conversations that involve different views to their own, and one in five Australians (19%) are extremely or significantly open to changing their current religious view (McCrindle, 2025).

Entrusted with the ministry and message of reconciliation (2 Cor 5:11–21)—not just strategies or programs—it's by being Jesus' witnesses and His Church, empowered by the Spirit, that each one can reach one: in our everyday conversations, over meal tables, and while doing life with people. By praying for and walking alongside those in need whom the Lord brings across our path, we follow the example of the early church in the Book of Acts—we get to 'gossip the gospel' about our Jesus, wherever we go.

Yes, we must continually rethink our methods and relearn how to communicate cross-culturally so people can truly hear the truth and grace of the Good News of Jesus Christ. But the gospel never grows old! It's the treasure every generation of Jesus' Church must keep, guard, and boldly proclaim.

Our CRC Evangelism Working Group would love to help resource you to expand the local evangelistic potential of your church. I am thrilled that there's been an increase in the number of churches offering Alpha across our movement. It's a fantastic tool to help people explore the big questions of life and faith through authentic relationships. There are resources you can access on our CRC website.

Together, we will once again unite for a National Day of Prayer and Fasting for Each One to Reach One, on November 1 2025.

## Administration

This year has marked significant progress in streamlining our core systems and data management processes, with a strong focus on delivering reliable, accurate, and accessible data to support compliance, reporting, and church engagement across our movement.

A key area of improvement has been enhancing the accuracy and usability of data across our systems. Accurate data underpins essential functions such as credential invoicing, church directory updates, website management, annual reporting, and broader communication. To improve efficiency, we have introduced several online forms that allow us to capture information more effectively. These changes will reduce administrative burden and support a coordinated approach to collecting data.

We were also pleased to appoint a dedicated staff member to provide website and technical support. This role is helping to integrate operations across platforms, align our digital infrastructure, and improve accessibility for all users.

A major project this year involved a review of the Childsafe Safety Management Online training system. Feedback received highlighted the need for a clearer, more manageable refresher training experience for credentialed pastors. In response, we have introduced a single-module refresher course for those who have previously completed the full suite of Childsafe training. To further simplify our duty-of-care framework, a new Pastors' Child Safe and Vulnerable People Code of Conduct has been developed. This will now form part of the annual credentialing process, providing a clear and consistent standard that pastors affirm each year.

In line with child safety compliance requirements, we also reviewed all pastors listed as "retired" and found that many remain active in ministry. As a result, we introduced two clearly defined categories of pastoral status:

Active: Engaged in any ongoing ministry or public representation

• Emeritus: Fully retired, with no ongoing ministerial function

This change ensures that all active pastors, regardless of age or role, meet current child safety and compliance expectations.

To support implementation of Childsafe systems at the local level, we recently launched the Administrators' Community of Practice. This 10-month structured program offers practical support to those responsible for church compliance. Each month, participating churches focus on one key area of compliance, building systems gradually through clear, achievable steps. This initiative reflects our commitment to equipping churches with realistic, scalable approaches to safety and governance.

These improvements are part of a broader commitment to operational excellence, pastoral care, and child safety. Our focus remains on:

- Refining our digital infrastructure
- Supporting pastors and churches with effective, user-friendly systems
- Strengthening trust and transparency in our processes

Special thanks to everyone who contributed to these initiatives—particularly our State Administrators; Thakshila Fernando, for his ongoing support with the Elvanto database; Emma Hura, who manages and integrates our website systems; and May Kirland who does the financial bookwork for National Office and Revival College.

#### Note 1: Summary of Significant Accounting Policies

#### (a) Basis of Preparation

This special purpose financial report has been prepared for distribution to the members to fulfil the financial reporting requirements under the CRC Churches International Australia Inc constitution and the Australian Charities and Not-for Profits Commission Act 2012. The board has determined that the entity is not a reporting entity.

CRC Churches International Australia Inc is a not-for-profit entity for the purposes of preparing the financial statements.

The financial report, except for the cash flow information, has been prepared on an accruals basis and is based on the historical costs convention. The amounts presented in the financial statements have been rounded to the nearest dollar. The financial statements are presented in Australian dollars, which is the functional currency of the entity.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054: Australian Additional Disclosures.

#### (b) Income Tax

The entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

#### (c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

#### (d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

#### (e) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from donors and any outstanding grant receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### (f) Employee Entitlements

Provision is made for the CRC Churches International Australia Inc's liability for employee entitlements arising from services rendered by employees to the end of the reporting year. Employee entitlements expected to be settled within one year, together with entitlements arising from wages & salaries and annual leave, which will be settled after one year, have been measured at their nominal amount. Other employee entitlements payable after one year have been measured at the present value of the estimated future cash flows to be made for those entitlements.

#### (g) Property, Plant and Equipment

Property, Plant and Equipment are brought to account at cost less, where applicable, any accumulated depreciation.

The carrying amount of Plant, Property and Equipment is reviewed annually by the Board to ensure it is not in excess of the future economic benefit of those assets. Individual items of plant and equipment in excess of \$500, which do not constitute a replacement, are capitalised.

Assets are depreciated on a diminishing value basis and the depreciation rates used for each class of depreciable asset are:

Furniture 10%-25%
Plant & Equipment 10%-25%

#### (h) Reserves

#### Reserves for Future Conferences

Funds have been put aside for use towards the annual national conference, and have been preserved for that purpose.

#### Missions Resettlement Fund

CRC Missions receive funds which are specifically designated to certain missions. These funds are recorded as revenue when received by CRC Missions and are recorded as an expense when the funds are paid to their designated purpose.

#### **Church Planting Funds Held**

Funds that are received for church planting are recorded as income when received and as an expense when paid to their designated purpose. Any remaining funds are preserved until spent.

#### (i) Revenue Recognition

The entity recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefit will flow to the entity and specific criteria have been met for each activity as discussed below.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

All revenue is stated net of the amount of goods and services tax.

#### Donations

Donations are recognised as revenue when received.

#### **Grants and Gifts**

Minor grants and designated gifts are recognised as revenue when received.

#### (j) Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

#### (k) Financial Assets

Financial assets are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the association's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amoritsation process and when the financial asset is derecognised.
